The Board of Directors of the Sachse Economic Development Corporation convened in a public meeting at 6:30 p.m. on Thursday, July 21, 2016, notice of the meeting having been posted as prescribed at the Sachse City Hall, 3815 Sachse Road, Building B, Sachse, Texas as required by Chapter 551, Local Texas Government Code. - 1. Meeting called to order at 6:31 PM by Mr. Hauenstein. Invocation offered by Mr. VanBuskirk and he also led in the pledges to United States and Texas flags.

- 16-3423 Approve the Minutes of the Sachse Economic Development Corporation regular meeting of June 16, 2016.
- 16-3432 Approve the Monthly Revenue and Expenditure Report for the period ending May 31, 2016 and the preliminary Summary Budget Report for June 2016.
 - Mr. VanBuskirk made motion to approve the Consent Agenda and motion seconded by Ms. Rhode. Motion was passed.

- 16-3424 Approve the preliminary 2016-2017 Sachse Economic Development Corporation Annual Budget.

This item was moved outside Consent Agenda for review due to change in several figures this week by Sachse Finance Director that weren't reflected in budget included in preliminary packet.

16-3431 The Community Development Director will provide EDC with a status update on the Comprehensive Plan.

Dusty McAfee outlined the ongoing process for Comprehensive Plan. Well over 100 residents met with consultants in April and charrettes were held in May. Consultants surveyed attendees at Red, White and Blue Blast. Surveys that targeted policy themes hit Facebook early in July. Two Woodbridge focus groups were held the 2nd week of July. More detailed surveys will drill deeper into key policy themes throughout the rest of summer. CPAC will begin meeting in late summer and early fall when Plan elements are ready for review. There has been a wide range of Sachse residents contacted and participating. Their general overview so far is to bring in more retail and restaurant options. Bush development to be maximized to pay for city services and maintain tax rate, 5th Steet should be reserved as a walkable urban downtown area with mixed use, SH 78 needs redevelopment, rehabs and beautification, better curb appeal (cleaner and nicer community in general), better parks and trails and more comfort level with urban living in Turnpike overlay and medium sized lots. The community has demonstrated excitement for the process and involvement has been high and diverse with public input process on-going. Input is not unanimous, but a majority has been observed on many key themes. Concept Plan for Turnpike area was extremely helpful at ICSC. Plan Sachse webpage reflects some of the findings and issues.

16-3427 Presentation by City of Sachse Fire Chief, Marty Wade, to update SEDC Board regarding departmental projects and priorities.

Sachse had 1825 annual calls answered last year. Fire Dept. works 24/7 responding to fires, medical emergencies, limited hazardous response, education, etc. Two fire stations have 3 fire lieutenants and Sachse may need third station at some point in the future. Most of work related to residential, not businesses. CFI accreditations are being pursued in the next few years.
