1. Meeting called to order at 6:31 PM by Mr. Bickerstaff. Invocation offered by Mr. Bickerstaff and he also led in the Pledges to United States and Texas flags.

#### 2. Consent Agenda

  - Working on illustrated map for new business development under construction and coming soon in Sachse
